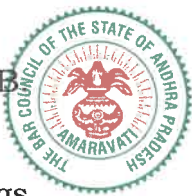

With reference to the subject cited above, I am to inform that the advocates qualified All India Bar Examination and completed 5 years, after passing the Examination, shall submit applications, under Rule – 9 of the **“Certificate & Place of Practice Rules, 2015”**.

Therefore, the Advocates of the following two categories shall submit the applications, though they have filed Declarations.

1. Advocates, Enrolled from 01-01-2010 to 31-12-2017 & passed All India Bar Examination **I to X**.
2. Advocates, Enrolled from 01-01-2010 to 31-12-2017 and passed Law Course, prior to 2009-10 Academic years.

The duly filled up applications can be sent to the Office of the Bar Council from 15-12-2022 to 13-01-2023 along with enclosures, mentioned in the application, by paying fee of Rs. 500/-, through SBI Challan.
