Sub:- Bar Council of Andhra Pradesh – Advocates obtained Loan of Rs. 10,000/- and Rs. 20,000/- during pandemic from the Funds of “Government Grant – Sanctioned to Bar Council of Andhra Pradesh” – Non-payment of Loan amount– Direction by the Special Committee to recover the Loan Amount by June, 2023 – Reg.

Ref:- Bar Council Circular R.O.C.No. 139/2023 dt. 10-04-2023

With reference to the subject cited above, I am to inform you that the Office as per the direction of Special Committee to the above reference as informed the Defaulting Advocates to repay the loan amount with interest on or before 30-04-2023, obtained Loan from the Funds of the Government Grant Sanctioned to Bar Council of A.P. to an extent of Rs. 10,000/- & Rs.20,000/-. Accordingly, some of the Advocates have cleared the total Loan Amount.

However, some of the Advocates have requested the Committee to extend the time and permit to pay the Loan Amount in Instalments. The Special Committee after considering the same as resolved to extend the time for two months, to facilitate the advocate to pay the due amount in two instalments i.e. in May & June, 2023.

Therefore, the Advocate, who are in due, shall clear the Loan Amount in two instalments in May & June, 2023, failing which the advocates are not entitled for any Financial Assistance in future, as informed earlier.

The advocates can check the due details <https://barcouncilap.org/loan-repayment-details> . The Instalments can be paid through SBI Collect payment gateway by selecting the Option either “Loan Repayment” for paying total due Instalments OR “Loan Partial Repayment” for partial payment.
