## Group Mediclaim & Personal Accident Policies to the Advocates for the year 2023-24 is finalized

The Bar Council of the State of Andhra Pradesh & the Special Committee under the Government Grant has finalized the "Group Medi-claim & Personal Accident Policies" to the Advocates for the year 2023-24.

Sri S.Sriram, Learned Advocate-General & the Chairman of the Special Committee and Sri Jyothi Prasad, the Regional Manager, M/s United India Insurance Company Ltd., have entered into a Memorandum of Understanding on 08-05-2023 for the Group Mediclaim and Personal Accident Policies for the benefit of Advocate community in the State. The Policy is tailor made Policy, that covers 1+3 i.e Self, Spouse and two dependent children and Personal Accident Policy, for the Advocates alone.

Under the said scheme, almost  $1/3^{rd}$  of the premium shall be paid by the concerned insured Advocate and the remaining balance amount will be paid from the Funds of the Government Grant and Bar Council of A.P.

The two kinds of policies will be as follows:

The Interested Advocates shall pay the part premium from 11-05-2023 to 10-06-2023 through SBI collect Payment Gateway https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=2657766.

The Advocates who submitted details of Insured Persons earlier, need not submit the data again. However, they can check the details through <a href="https://barcouncilap.org/health-insurance-scheme/">https://barcouncilap.org/health-insurance-scheme/</a>. The Advocates, who have not submitted the Insured Persons details can submit the same through <a href="https://barcouncilap.org/apply-health-insurance-scheme/">https://barcouncilap.org/apply-health-insurance-scheme/</a>. The policy will come into effect from 15-06-2023.

Therefore, all the Advocates in the State are informed to utilize the opportunity and avail the benefit of Insurance Policy.
