The Office through the above references has informed the advocates, who are in default, to repay the Loan amount, obtained from the **“Government Grant Account”** to an extent of Rs. 10000/- and Rs. 20000/-. In spite of the said Circulars, most of the advocates have not paid the Due Amount. In this connection, the Council has received requests from the Advocates & the Bar Associations, requesting to provide Instalments for payment of due amount.

On their request, the Bar Council has resolved to provide four instalments to clear the loan amount and issued Circular through 3<sup>rd</sup> reference. Since, most of the advocates have not cleared the amount, time is extended till 31-03-2024.

Therefore, I am herewith enclosing the list of Advocates, who are in default and request you to take steps that the Advocates shall pay the due amount “in total” or by “four instalments” through online “SBI Collect payment gateway”. The payment link is enabled from 04-02-2025 to 31-03-2025.

- i) For payment of Total due amount select “Loan Repayment” option
- ii) For payment of Due amount in instalment select “Loan Partial Repayment” option.

Hence, I request you to place the Circular on the Notice Board of the Bar Association for information of the Advocates and see that the Advocates shall pay the due amount immediately.
