I am to inform you that M/s. National Insurance Company Ltd., who offered “Group Mediclaim & Personal Accident Policies” to the Advocates for the year 2024-25, has not provided policies, since only 3992 Advocates have paid Premium.

However, the Bar Council pursued with other three Nationalized Insurance Companies continuously for the last two months to bring the Policies to the Advocates for the 4th consecutive year also, and prepared to offer more premium from the funds of the Bar Council, apart from the premium received from the Advocates. Though the Council made all efforts, no Insurance Company came forward.

Hence, the Bar Council in its meeting held on 23-03-2025 resolved to refund the part premium paid by the Advocates, as there is no other alternative to the Bar Council and to requests the Advocates to understand the situation and to cooperate in this regard.

Therefore, I request you to inform the Advocates of your Bar Association, who paid part premium amount towards Insurance, to submit their Account details through online Digital Application by entering the Enrolment Number. The 1st page of passbook / Account Statement showing the particulars of the Account shall be attached with the application. To submit the details, the link will be enabled from **01-04-2025 to 20-04-2025**.

After furnishing the Account details by the Advocates, the amount paid by the Advocates will be transferred to their respective Accounts.

I request you to place the circular on the Notice Board of the Association for information of the Advocates.
