NOTIFICATION

The Bar Council of the State of Andhra Pradesh has published the “**List of Non-Practising Advocates**” through Notification dated 15-12-2022 under Rule – 20 of the “Certificate & Place of Practice Rules, 2015.

After publication, the Office has received applications for Resumption of Practice and the Administrative Committee has allowed 265 Advocates to Practice, and the same were notified.
